







# Initiate a project proposal





- Access "EEA Grants RO-NO 2018" to initiate a new project proposal

#### **Basic Project Data**


- All fields are mandatory
- "No. of Partners" field affects next forms
- Some fields are automatically calculated from other fields or forms






#### **List of Participants**


- List of Participants is generated based on "No. of Partners" selected in previous section
- For Romanian Organisations fields are activated after filling in CUI (Unique Identification Code) and pressing "Load Organisation Fields..." button
- Mandatory fields are marked with a red star






#### **List of Participants – Project Promoter**


- "Organisation name" is filled in automatically based on CUI
- Romania is preselected as Project
   Promoter "Country"
- For Romanian Organisations State Aid Declarations fields are based on the value selected in "Entity type" field
- For Project Promoter "Entity type" is preselected to Research Organisation






### **List of Participants – Project Partner(s)**


- Organisation fields are activated after selecting country
- For other Countries than Romania some fields are not requested (CNP, CUI, County)
- If Romania is selected as Country, CUI is requested (same case as Project Promoter)






#### **Thematic Areas and Keywords**


- For interdisciplinary projects two more Thematic Areas/Key Topics can be selected
- Only Main Thematic Area and Main Key Topic are mandatory






#### **Key Persons**


- Principal Investigator and Team
   Leaders are automatically imported
   from "List of Participants" section
- Other Key Persons may be added using the available button
- CNP mandatory for Romanian persons






#### **Project Plan**


- Phases, Activities and Partners can be added using buttons from the right column
- Programme/Own Budget must comply with State Aid Scheme (based on "Entity Type" and "Category of Activity")






#### Requested Funding per Participants and Years


 All information is imported and calculated from "Project Plan" section







#### Budget breakdown by category of expenses and partners share


- Must be filled in for every partner and every year
- Total per year and partner will be checked against total from "Projects Plan" section












#### **Verify/Finalize**


 Custom made validation functions allow finalizing only if filled in information is valid (mandatory fields, eligibility criteria, State Aid Scheme)







#### **Verify/Finalize**
